NOTICE

In pursuance to the New Coal Distribution Policy (NCDP) pronounced by Ministry of Coal, Government of India, vide Office Memorandum no.23011/4/2007-CPD, dated 18.10.2007, in supersession of existing coal distribution policy for core and non-core sector and other instructions issued in this regard from time to time, this is for information of all concerned / public at large that the earlier system of supply of coal through linkage system is to be replaced/superseded by executing Fuel Supply Agreement (FSA) between S.E.C.L and its valid linked consumers. All existing valid linked consumers of SECL are requested to conclude Fuel Supply Agreement (FSA) with S.E.C.L. by completing all the required formalities, at the earliest. It may be noted that failure to enter into FSA with SECL by the existing valid linked consumers on or before 30th April 2008, shall result in discontinuation of coal supplies at fixed prices. Existing valid linked consumers of SECL are also being intimated individually.

As regards supply of coal for meeting the requirements of small and medium sector (requirements less than 4200 Metric Tons per annum) through State Agencies/NCCF, the allocation of coal w.e.f. 01.04.08 will be made only to the agencies notified by State Governments and subject to their executing the FSA with SECL.
